BYLAW NO. 161-2020

A BYLAW TO AUTHORIZE THE RATES OF TAXATION TO BE LEVIED AGAINST ASSESSABLE PROPERTY WITHIN THE Summer Village of Bonnyville Beach FOR THE 2020 TAXATION YEAR

Whereas, the **Summer Village of Bonnyville Beach** has prepared and adopted detailed estimates of the municipal revenues and expenditures as required, at the council meeting held on March 6, 2020; and

Whereas, the estimated municipal expenditures and transfers set out in the budget for the **Summer Village of Bonnyville Beach** for 2020 total \$89,594.20; and

Whereas, the estimated municipal revenues and transfers from all sources other than taxation is estimated at \$19,405.17 , and the balance of \$70,189.03 is to be raised by general municipal taxation; and

Whereas, the Council of the Municipality is required each year to levy on the assessed value of all property, tax rates sufficient to meet the estimated expenditures and the requisitions; and

Whereas, the Council is authorized to classify assessed property, and to establish different rates of taxation in respect to each class of property, subject to the Municipal Government Act, Chapter M-26, Revised Statutes of Alberta, 2000; and

Whereas, the assessed value of all property in the **Summer Village of Bonnyville Beach** as shown on the assessment roll is:

NOW THEREFORE under the authority of the Municipal Government Act, the Council of the **Summer Village of Bonnyville Beach**, in the Province of Alberta, enacts as follows:
