## Taxes and Assessment

Your Tax notice from the summer village is a combined notice of assessment and taxes due.

Your assessment is done by a qualified assessor. The date of assessment is July of the previous year and is determined by the market forces in the local area. Unfortunately the costs involved in running the village have gone up a bit but the council and administration have tried

to keep the taxes as low as possible.. For 2017 most rate payers will see a small increase in the tax bill, since we have an increase in Education taxes and the requisition from the Seniors foundation in Bonnyville

Taxes are due and payable in full by June 30th of the year. Penalties will be applied to late payments as noted on the tax notice. ## Monthly Installment Payments

We do have a plan for people who wish to make monthly payments on the taxes. The calculated amount is provided to those on installments with the tax notice.

**If you wish to start monthly payments, your current tax bill will be divided into 6 equal payments (July-December) of this year and the installments for 2019 will be calculated to start in January of that year. Regulations do not allow for extending tax payments beyond the end of the current year.**

**Please note that installment requests must be made prior to June 15th to allow for setting up the schedule prior to June 30th to avoid penalties.**

To Set up installment payments for 2018/19  
email the administration.

Payments for taxes would be calculated as:

Current year taxes / 6 for the amount from July thru December.

Estimated payment for January thru June of 2019 would be the current taxes / 12—rounded up to even dollar amounts applied as credit memo to your account.

The remainder of 2019 taxes would be spread over the next 6 months (July-December)

All installment checks / payments are due for deposit on the 15th of the month.
